24th National Conference of the University of the Philippines Lipunang Pangkasaysayan (U.P. LIKAS) & 3RD National Leadership Training for Supreme Student Government SSG/Classroom Officers & Advisers

1. The Department of Education–Schools Division Office of Ligao City is encouraging our teachers to attend and participate in the **National Conference of the UP-LIKAS with the theme Komonwelt: Landas Tungo sa Kalayaan at Kasarinlan on September 25-26 at the NISMED Auditorium, UP, Diliman, Quezon City.** Likewise, for our students and SSG Advisers to the **National Leadership Training for Supreme Student Organization Organization/Classroom Officers and Advisers on October 9-11, 2015 at Teachers Camp, Baguio City.**

2. The activities aim to:

4. Participation of both public and private schools shall be subject to the non-disruption-of-classes policy stipulated in DepEd Order No. 9, s., 2005 entitled Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance Therewith.

5. Participation of the participants shall be on Official Time.

6. Travel and other incidental expenses of the teachers to UP-LIKAS shall be borne by the participants, however, expenses relative to Leadership Training can be charged to the SSG funds.
