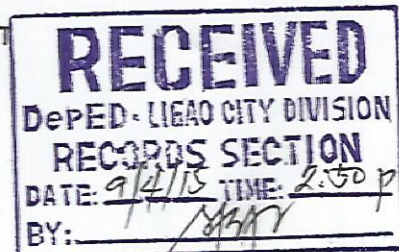

2. The said tournament aims to:

3. General guidelines of the activity:
